24/7 ACCESS AGREEMENT

Use of the Parker YMCA outside of staffed hours of operation is for YMCA of Northern Rock County members only. **Members must be at least 18 years of age**, have purchased access and must use their assigned key card to gain entrance. **Underage family members (13+) on my account may use 24/7 under my direct supervision.** Access to the Parker YMCA via a key card purchased by me is for my individual access only and I will not permit my card to be used by any other person to gain access to the YMCA. Family members on my membership cannot use my 24/7 Access, even if I am present. **Key card sharing is strictly prohibited and may result in membership suspension or cancellation.**

- 24/7 Access is available for the Parker YMCA only. Entry to the YMCA outside of staffed hours of operation is through the YMCA's main entrance. The YMCA of Northern Rock County reserves the right to deny or limit access to any person, or to discontinue or modify the 24/7 Access program, terms or conditions, at any time.
- We HIGHLY recommend that you have an adult workout partner, who has a membership with the YMCA of Northern Rock County and has purchased a key card, accompany you while using the YMCA 24 hour access facility, but it is entirely up to you. You have agreed to purchase a membership key card which will allow you access to the Parker YMCA outside of staffed hours of operation. As such, you are aware that there will be no supervision or assistance when using these facilities outside of the YMCA's staffed hours of operation. You are also aware that if you are injured, become unconscious, suffer a stroke or heart attack, that there will likely be no one to respond to your emergency and this facility has no duty to provide assistance to you. Even though this facility is equipped with surveillance cameras, it is likely that should you require immediate assistance, none will be provided.
- Because physical exercise can be strenuous and subject to risk of serious injury, the YMCA of Northern Rock County urges you to obtain a physical examination from a doctor before using any exercise equipment or participating in any exercise activity. You agree that if you engage in any physical exercise or activity, or use any YMCA amenity on the premises, you do so entirely at your own risk. You agree that you are voluntarily participating in the use of this facility and assume all risks of injury, illness, or death. The YMCA of Northern Rock County is also not responsible for any loss of your personal property.

This waiver and release of liability includes, without limitation, all injuries which may occur, regardless of negligence, as a result of; (a) your use of all amenities and equipment in the facility and your participation in any activity, class program, personal training or instruction; (b) the sudden and unforeseen malfunctioning of any equipment; (c) your slipping and/or falling while on the Parker YMCA premises, including adjacent sidewalks and parking areas.

- Snow removal will not be enforced until staffed hours of operation. Members with 24 hour access can utilize the Parker YMCA, but do so at their own risk from the elements.

By signing this document, you acknowledge that you have carefully read this "waiver and release" and fully understand that it is a release of liability. You expressly agree to release and discharge the YMCA of Northern Rock County and all affiliates, employees, agents, representative, successors, or assigns, from any and all claims or causes of action. You agree to voluntarily give up or waive any right that you may otherwise have to bring a legal action against YMCA of Northern Rock County, Inc for negligence, personal injury or property damage.

****Note: Should any part of this agreement be found by a court of law to be against public policy or in violation of any state statute or case precedence, then only that wording is removed and the remainder of this agreement will remain in full force.**

I agree to adhere to all policies of the YMCA.

I have read and understand the following safety and security measures listed here and in the 24/7 Access Policy, specifically including (please initial):

- ___ My 24/7 Access privileges are for my own use only. Allowing another person into the Y on my key card is grounds for immediate termination of my membership. 24/7 Access does not extend to guests that I bring into the facility.
- ___ 24/7 Access is for the adult members (18+) only. Underage family members (13+) on my account may use 24/7 under my direct supervision.
- ___ The 24/7 Access areas are restricted to the Wellness Center and Gymnasium only, not the rest of the YMCA.
- ___ During inclement weather, snow removal will not be conducted 24/7 and the parking lot and walkways might have slippery conditions. I understand and will use at my own risk.
